4) Mode of Measurement

- b) For Rates Quoted in Sqft Measurement shall be as per actual work carried out on site and measured in Sqft given.

5) Mode of Payment

Rates shall be quoted including CGST + SGST.

a) For Sqft Items

Payment shall be released after satisfactory completion of each work in total.

b) For Rates Quoted in Sqft.

Payment shall be released after completion of at least 50% of work.

Running bills shall be made for minimum amount of 3.00 Lakhs

TDS or any other taxes shall deducted from the Running Bills.

Presently Bank is in working condition at the premises and during working of tendered items of work the working of bank shall NOT be disturbed and satisfactory completion of work in time limit is the essence of the contract.

SPECIAL CONDITIONS

- 1. A schedule of probable quantities in respect of each work and specification accompany these special conditions. The schedule of probable quantities is liable to alterations by omission, deductions at the discretion of the Bank. Each Tender should contain not only the rates but also the value of the each items should be total in order to show the aggregate value of the entire Tender. All corrections in the Tender schedule shall be duly attested by the dated initials of the Tenderer.
- 2. The tenderer must obtain for himself on his own responsibility and at his own expenses all the information which may be necessary the purpose of making a Tender and for entering into a contract and must consider and inspect the site of the work and acquaint himself with all local conditions, means of access to the work, nature of the work and all matters appertaining thereto. At present Bank is in working condition at the premises and during the said work, working of the Bank shall not be disturbed.
- 3. The rates quoted in the tender shall include all charges for double scaffolding, centering materials, water and meter charges, temporary plumbing, hire for any tools and plants, sheds for materials, making out and the clearing of site and watering the concrete as mentioned in the specifications. The rates quoted by the tenderer in the schedule of probable quantities will be deemed to be for the finished work to be measured in site. The rates shall be inclusive of GST, Octroi duty. Works contract Tax, or any other duty levied by and Government of Maharashtra of Public Bodies. The rates shall be firm and shall not be subject to variations.
- 4. Rates for items which are not included in schedule of quantities shall be settled by the Bank.
- 5. The contractor on starting the work shall furnish to the Bank a programme for carrying out the work stage by stage in stipulated time. The record showing the progress of work weekly shall be maintained.
- 6. The contractor must not assign the contract. He should not sublet any portion of the contract except with the written consent of the Bank.
- 7. The contractor will be responsible for the safety and structural soundness of the Building during progress of all the work and for a further defect liability period of 12 months form the date of completion. Any defects in workmanship or materials during the time of works progressing or the maintenance period shall replace or made good by the contractor at his own cost as provided in the contract.
- 8. All debris or rubbish shall be carried away from inside or all around the building at the end of the day, every day contractor should keep the premises clean and neat.
- 9. Contractor should ascertain quantity/ size of each required item & mention modified quantity/ size of the items.
- 10. If there in any difference in quantity/ size of any item, prior approval of bank must be obtained with proper explanation.
